## Kuramathi Babysitting Service

### Terms and conditions:

- A minimum of 24 hours advance notice is required to reserve a Babysitter
- A minimum 1 hour reservation is required per appointment. If the appointment is less than 1 hour, the charge will still apply
- Kuramathi Kids Club Babysitting services operates on a first come, first served basis. Booking is guaranteed based on the availability of Babysitters
- Babysitters are available 24 hours (Babysitting services can be provided in the villa only after the Kids Club closes)
- Kuramathi Kids Club Babysitting Services reserves the right to confirm the number of Babysitters needed based on the below mentioned ratios/ages
- For all resort guests, a Babysitter can be booked to care for your child/children in your villa and in the Kids Club.
- All the Babysitting Services are provided to children of 0 – 12 years old
- The Babysitting Services is chargeable at US\$ 10 per child ( 19.30hrs – 22.00hrs ) US\$ 15 per child ( 22hrs -24hrs ) only in the Kids Club
- US\$15 per child ( 19.30hrs – 24hrs ) US\$ 25 per child ( after midnight – 07.00hrs ) and US\$ 15 per child (07.00hrs – 08.30hrs) in villa.
- Additional sibling(s) of ages 3 years or older are given 50% discount
- Please note, no direct cash transactions are permitted with the Babysitter

### In-Room Ratio

- Children over 36 months = 1 Babysitter : 2 children
- Children under 36 months = 1 Babysitter per child

### Outdoor (on property) Ratio

- Children over 36 months = 1 Babysitter : 2 children
- Children under 36 months = 1 Babysitter per child

### Cancellation Policy

- Kuramathi Kids Club Babysitting Services reserves the right to charge 1 hour if the guest wishes to cancel their babysitting booking within 3 hours of the appointment. No charges will be levied if the booking is cancelled 3 hours prior to the appointment.
- A 15 minute grace period is given to the guest from the arrival of the babysitter in the villa or for the guests to arrive at the Kids Club. After this 15 minute grace period, if there is no contact from the guests, it will be considered a No Show booking. For No Show bookings, the Kids Club reserves the right to charge 1 hour of Babysitting service to the guests.

In the event of an emergency, I hereby authorize the Sitters, the Hotel, its employees and/ or their designated medical professionals to make emergency medical decisions for my child/ children and/ or to administer emergency medical assistance to my child/ children. I accept responsibility for payment of expenses incurred as a result of any medical treatment provided to my child/ children.

In consideration for my child/ children being allowed to participate in the Babysitting Services and be attended by the Sitters, I agree to INDEMNIFY AND RELEASE the Hotel, the Hotel's owner, the Hotel's operator and ..... and their respective directors, employees, agents and representatives of each of the foregoing (including but not limited to the Sitters), from and against any and all liability, claims, demands, actions, loss and damage, including but not limited to liability arising from any damage to or loss of personal property, or any injury sustained by, me or my child/ children arising out of or in any way connected with participation of my child/ children in the Babysitting Services, including any damages arising from the provision of emergency medical treatment.
